1. **CLOSING DATE FOR ENTRIES AND PAYMENT: 10 June 2016 at 23H00**  
***(No payment – No entry !)***
2. **ONTTREKKINGS/WITHDRAWALS.** Neem kennis dat **geen terugbetaling** van onttrekkings gedoen sal word na **15 Junie 2016** as dit nie deur 'n Veearts of Mediese sertifikaat vir perd of ruiter en die Amptelike Onttrekkingvorm vergesel is nie(- 25% Admin Fooi)  
  
Take note that **no refund** for withdrawals will be accepted after **15 June 2016** unless accompanied by a Veterinarian or Medical Certificate for horse and or rider and the Official Withdrawal Form (- 25% Admin Fee).
3. **SUBSTITUTION OF HORSE OR RIDER.** Substitutions of a Horse or a Rider will be allowed until Monday **3 July 2016 at 12h30.**
4. **KWALIFISERENDE VEREISTES VIR DEELNAME/ QUALIFYING REQUIREMENTS.**  
  
Die ruiter en die perd moes elkeen 3(drie) suksesvolle ritte vanaf Fauresmith 2015 tot en met 31 Mei 2016 gery het om te kwalifiseer vir die rit. Die ruiter en perd het nie nodig om 'n kombinasie te wees nie **of** 2 x 120km .

Die ruiter en perd al twee Fauresmith ritte klaargemaak met die laaste Fauresmith rit binne 24 maande hof die ruiter en perd net 1 x 80km klaar te maak binne die periode soos bo genoem.

Die ruiter en perd 2015 Fauresmith klaargemaak hoef die ruiter en perd net 2 x 80km binne die periode soos bo klaar te maak.  
  
The rider and the horse must have each completed 3(three) successful rides from Fauresmith 2015 to 31 May 2016 to qualify for participation in the event. The rider and or horse do not have to be a combination **or** 2 x 120km.  
**OR**  
If the rider and horse have completed two Fauresmith's with the last Fauresmith being in the last 24 month period only 1 x 80km has to be completed in the period as set out above to qualify.  
**OR**

The rider and horse completed their first Fauresmith in 2015 they only need to complete 2 x 80km ride to qualify for Fauresmith 2016.

5. **ERASA RULES.** ERASA rules will apply for the duration of the event - members must ensure they are up to date with the ERASA rules.
  6. **COURSE DISTANCE** : 200km
  7. **LEG DISTANCES** (±) Day 1 - 74km  
Day 2 - 74km  
Day 3 - 52 km
  8. **COMPLETION TIME FOR RIDE.** 16 Hours - Riders must be able to ride at a minimum of 13kmph to complete the ride in the 16 hours.
  9. **ACCESS TO/ON COURSE NOT ALLOWED.** No rider, groom, family member, friend/s, team manager/s or any other person related to a rider will be allowed access on any farm or parts of the course other than the national official gravel roads surrounding the showground area prior to the ride. Any person found in transgression of the above will be denied the opportunity to participate in the event.
  10. **PROPER RIDING CLOTHING.** Members must ensure that they wear the correct clothing for RIDING PURPOSES on arrival and for the duration of the event.
    - ClubT Shirt/Drimac/Sweater/Shirt for those riders not participating in a Union/ERASA team during the competition is preferable
    - Jodpurs/ breeches or long trousers
    - Proper shoeing/leggings/boots(safety stirrups advisable)
    - Correct HARDHAT/SAFETY RIDING HAT for horse riding purposes  
(Cycle Helmets are not advisable)
  11. **PARADE.** The format of the parade is in a dismounted format. Clubs/Unions are required to display Club/Union clothing/banners/flags/horse blankets as part of a showpiece for the opening/closing parade ceremonies.
  12. **STABLING** Brick (200 available) and Temporary stables (only 65 available) – no bedding, bedding can be bought on the campsite - Stable no will given to each competitor who requests stabling.  
**A spot fine can be imposed if horse in incorrect stable.**
  13. **OWN ERECTED CAMP/PADDOCK.** No horse will be accommodated on a campsite.  
Own Paddocks may be erected in the allocated areas provided. All members who plan to erect or have an already erected paddock on the showground's must pay an R 50, 00 ground levy per horse. The self-erected camp/paddock must be of such a nature that a horse cannot break free during the day or night.  
**A spot fine of R500 per horse will be imposed on any horse that breaks out of a stable and or paddock from arrival until departure at Fauresmith 2016.**
- It is advisable that all self-erected camps be erected in the fenced area at the stables to ensure that those horses that are escape artists be kept in a fenced area at night - it will ensure that no horse will wander off at night.
14. **ERASA PADDOCKS.** Only **80** Wooden(3m x 3 m) paddocks are available at R100,00 each for the duration of the event.  
**A spot fine can be imposed if horse in incorrect paddock.**
  15. **KAMPEERPLEK.** Uitstallers wat gebruik maak van staanplekke, sal daarvoorbetaal.Geen uitbreiding van kampplekke deur deelnemers en/of besoekers saam met uitstallers sal toegelaat word nie.
  16. **STALNOMMER/S.** **Stalnommers moet aangedui word deur eienaars.** Indien eienaars stalle wil uitleen tydens die byeenkoms, moet 'n toestemmingbrief deur die eenaar uitgereik word aan die "Lener" met die korrekte stalnommer - die brief moet gefaks word na 086 245 1584 of epos word na erasagm@telkomsa.net sodra inskrywing gedoen word.  
**GEEN brief sal na die sluitingsdatum van 10 Junie 2016 om 23H00 aanvaar word nie.**

Die organiseerder sal namens ERASA stalle toeken wat nie deur eienaars gebruik word nie aan ander lede wat stalle bespreek.

17. **ONDERTEKENING VAN VRYWARINGSVORM.** Lede moet hulself vergewis of die ERASA vrywarings vorm geteken en ingedien is by die Algemene Bestuurder of die Bloemfontein kantoor soos bepaal in die reëls vir deelname aan enige ERASA rit.
18. **BEHANDELING WAT PERD/E VOOR AANVANG VAN FAURESMITH 2015 ONTVANG HET VERBODE MIDDELS.** Alle behandeling/s wat die perd ontvang het tot en met Fauresmith moet met die nodige dokumente/besonderhede van die veearts by wie die perd behandeling /medikasie ontvang Verbode Middels soos op die ERASA Webtuiste gepubliseer.
19. **ELECTRICITY/POWER SUPPLY.** Every rider/family member/friend that accompanies a rider/s to Fauresmith is requested to assist in the energy saving effort. The transformer at the Showground's has limited capacity and members are requested not to bring water containers and or devices to be connected to the electricity supplier on the showground's unless it is used on fire/gas.  
No washing machines tumble dryers, electrical kettles, urns and heaters that cause constant electrical failures will be allowed –unless you are prepared to a have constant power failure and your neighbours on your back.  
**Own generators are welcome if members want to make use of any of the abovementioned luxuries**
20. **FIRE EXTINGUISHERS.** It is advisable and important that all members who plan to camp be prepared to have a fire extinguish on his /her campsite in an emergency situation for camping purposes. Fires must preferably be extinguished at night before bed time or be under control and enclosed for the night to ensure safety of all in the camping area.
21. **BAD BEHAVIOUR.** No bad behaviour in any form will be tolerated against a fellow rider, groom, official or local member in town and or damage of property on the show grounds and in town from the moment you step foot in the town of Fauresmith, Fauresmith Showground and surrounding areas/farms/towns. Strict law enforcement will be in place by local authorities, organiser, and camp commandant and securityservice before and during the event with regards to liquor abuse, driving without licences, speeding and or any misbehaviour. Please bear in mind that ERASA and for that purpose riders, friends, family and grooms are **VISITORS** to the town of Fauresmith, and it is expected of all to behave in a proper manner at all times.
22. **HORSE PASSPORTS.** No horse will be allowed to participate if the ID of the Horse is done incorrectly or vaccinations as required/prescribed by ERASA are not up to date. Horses must be micro-chipped.
23. **STALLIONS.** Stallions must be under control at all times and identified as prescribed with a yellow ribbon in the tail from arrival on the premises until departure.
24. **NO HARD HAT/SAFETY HELMET - NO RIDING.** Nobody will be allowed to ride a horse on arrival, before and during the at Fauresmith without a proper hard hat as prescribed for participation.
25. **KLUB NOMMER BEFFIE.** Alle ruiters moet verseker dat hul eie klub nommer beffies saamgebring word om mee te ry soos enige ander ERASA rit. Springbok nommers word **nie** gebruik tydens die nasionale rit nie – lede wat dit gebruik moet verseker dat hul eie klub nommer beffie gebruik word. Lede moet verseker dat die beffie /T-hemde wat self gemaak is met 'n klub nommer aan die voorgeskrewe vereistes van ERASA voldoen.  
**Geen tydelike of dagnommers sal toegeken word vir deelname nie**
26. **EXHIBITORS.** No horse health products/supplements, other than “STRIDE” may be sold or advertised at the Fauresmith 2016 event. Other exhibitors that exhibit on camp sites must get the necessary authority from the Coordinator before any product/banner may be displayed or product sold. An official Permit will be issued by the Coordinator that must be displayed at all times by all Exhibitors.  
No exhibitor/s with any related horse goods will be allowed to display or sell any product outside the premises of the Showgrounds and or Bowls Club.  
**No Food or Beverages other than that sold by the Fauresmith Agricultural Society in the Cafeteria will be allowed.**  
A dedicated area's will be provided to exhibitors.
28. **REGISTRATION OF WORKERS.** All local labour/workers and or grooms must be registered on arrival – a name and campsite number and or rider name must be provided to allow workers to enter the

Showground's. The security company on duty are tasked to remove any worker who is not registered from the showground's/campsite areas.

A fee of R30,00 will be payable to Fauresmith Agricultural Society on registration of such worker/labourer/groom does not matter if the worker accompany rider from home.

29. **SECURITY/ENTRANCE CONTROL.** A security company is appointed to control aspects of access/entrance control and some safety issues on the premises. For security purposes all vehicles and or visitors will have to comply with the arrangement or access control at the gates. Safety and security inside and outside the camp area is not solely the responsibility of ERASA or the organiser, members and or visitors share the responsibility to secure private property. Everybody is called upon to lock up valuable goods, zip up tents at night, and lock caravans and vehicles when not attended to. Do not leave anything open at night as neither the organiser, camp commandant nor the few roaming guards can attend to all campsites at once to ensure everyone's private property is protected. Do not leave horse blankets, halters or riding equipment on fences, paddock fences or stable doors unless attended to. Report all strangers to the security personnel who will be able to manage the situation.
30. **PHYSIOTHERAPISTS/BODY WORKERS/ FARRIERS & OTHERS.** A dedicated area's will be provided. Applications to work at Fauresmith 2016 must be forwarded to the Coordinator. No work/rendering of services will be allowed outside the premises of the Showground's.
31. **MEDIA COVERAGE.** Media coverage must be approved by ERASA Council and the Organiser of the event. If any member plans to obtain crews to film/cover the event, it must be authorised in advance. The intent is to make sure that proper editing is done after the event to ensure that the correct detail is provided to prevent any discomfort/unhappiness. A media liaison officer for Fauresmith 2016 will be appointed and all media liaison will work through this member at Fauresmith after proper authorization.

## **ONLINE ENTRY PROCEDURE FOR FAURESMITH 200 :2016**

- The ERASA online entry system will be used for Fauresmith 200: 2016.
- The system will enable you to enter from the ERASA registered database of riders and horses (Please make sure that your horses have been activated by ERASA – you can check with Nickey or Ansie at the Bloemfontein Office)
- Your payment will be linked to a system generated reference number, kindly use the number as your payment reference. Please keep in mind that the **closing date for entries and payment is 15 June 2016 at 23H00**
- All entries for the event will be displayed in real time. You do not need to log in to check your entry or to enter.
- Ride costs will be calculated automatically by the system, depending on your choices in terms of entry fee, stable or paddock requirement, camp sites etc.
- Each rider must be entered separately by using the member's club number.
- A manual on how to enter will be posted on the ERASA website under the Fauresmith TAB and sent to all clubs
