3.1.1. Korporatiewe lidmaatskap het nie stemreg nie.

3.1.2. Korporatiewe ruiters moet deur die novice reëls gaan soos enige ander ruiter.

3.1.3. Korporatiewe lidmaatskap word beperk tot plaaseienaars en gasteplaas eienaars en hulle perde.

3.1.4. 'n Senior korporatiewe ruiter mag senior vir 'n kinder ruiter wees.

COUNCIL DECISION

1.1.1. Corporate members does not have any voting rights

1.1.2. Corporate riders/horses must go through the normal novice qualification procedures as all other riders.

1.1.3. Corporate membership are only for farm and lodge owners.

1.1.4. A senior corporate rider may be a senior to a child rider.
